



Terms and Conditions

Wheelie Great Pizzas is committed to your event being exactly as you require. The following terms and conditions of our agreement are outlined to clarify the products and services you have chosen and agreed to purchase.

INITIAL DEPOSIT

A deposit of \$250.00 is due at time of booking. Wheelie Great Pizzas cannot guarantee any booking until this deposit is received. Receipt of your deposit and signed contract will confirm your order.

FINAL PAYMENT AND NUMBERS

Final numbers and full payment are required 2 weeks prior to the scheduled event. This will be the minimum charge for the event. No refunds or deductions will be given for decreased numbers after this date. Any additional costs incurred due to increased numbers or additional items requested will be charged and due within 7 days of invoice.

CANCELLATION

If a confirmed booking is cancelled, you must submit notification in writing to our office as soon as possible. Cancellations will incur the following costs:

Anytime up to 14 days prior to hire commencement date – \$150.00

Less than 14 days prior to hire commencement date – \$250.00 - Deposit forfeited

If full payment has been received, and the event is cancelled within one week of the event, the full amount paid minus wages and travel costs will be forfeited.

DELIVERY OF SERVICES AND GOODS

Wheelie Great Pizzas will provide the contracted goods and services on or before the confirmed date of the event as agreed upon. The Client is responsible for providing accurate details of service location and gaining access to the venue of the event for delivery and service of goods.

DAMAGE TO HIRED/LEASED ITEMS

Any damage caused by the client or client's guests, other than normal wear, to any goods provided by Wheelie Great Pizzas is the responsibility of the client.

The client will be liable to replace at current replacement value any items damaged or unreturned from the event. The client will be invoiced separately for the additional amount to be paid within 7 days of the invoice.

ADDITIONAL SERVICE TIME

Preferably additional service time will be requested prior to the event. If additional time is requested during the event it is up to staff discretion and food availability to continue service over and above the booked time. If available, additional hours will be charged at \$40.00 per hour per staff member (usually 2) and must be agreed to and signed for by client.
